Concessions Update:

- Working on setting up trainings for spring sports and the dates and times will be posted on our website.

Treasurer's Report:

- Year end memberships total \$2785.00. Received some donations, but these are earmarked for another use.
- Matt will have credit card processing ready this week even if he has to put his name on the account.
- Can we do a direct appeal to spring coaches regarding increasing memberships?

- Matt will set up the credit card processing and make the link available.
